Single Share Policy - Cabine accommodation is based on double occupancy. If you are travelling alone, a same sex room mate may be assigned to your cabin.
Deposit - A completed booking form and a 30% non-refundable deposit are required to confirm your reservation aboard the Odyssey.

Final Payment - Final Payment is required **no later than 60 days prior to departure**. Failure to provide final payment 60 days prior to departure will result in cancellation of the booking and forfeiture of any deposit.

Cancellations- If a booking is cancelled less than 60 days prior to departure, or, if a passenger fails to arrive, the total cruise value is forfeited.
